CMS Update

The Centers for Medicare and Medicaid Services (CMS) has issued two new Survey and Certification Letters pertaining to nursing homes.

S&C 11-38-NH: Food Procurement Requirements

CMS issued Survey and Certification Letter # 11-38-NH pertaining to compliance with food procurement requirements for nursing homes with gardens producing foods for residents. Facilities with nursing home gardens are compliant with the food procurement requirements at 42 CFR 483.35(i), Sanitary Conditions, Tag F371 as long as the facilities have and follow policies and procedures for maintaining the gardens.

The facility should immediately report any outbreaks of food borne illnesses, from any cause, to their local health department. Surveyors should request the policy and procedures for maintaining nursing home gardens if there is an outbreak of food-borne illness and the facility's primary food service source has been rule out as the cause of the outbreak.

S&C 11-37-NH: Advance Copy of Issuance of Revisions to Interpretive Guidance at F tag 322, as Part of Appendix PP, State Operations Manual (SOM)

CMS issued Survey and Certification Letter # 11-37-NH pertaining to F322. CMS made changes to surveyor guidance for feeding tubes in Appendix PP of the SOM to provide clarification to nursing home surveyors when determining compliance with the regulatory requirements for feeding tubes. The regulatory language will remain unchanged. CMS deleted F tag 321 which contained language about not using feeding tubes unless unavoidable, and incorporated the guidance into F tag 322.

This revision will be implemented on November 30, 2011. At that time, a final copy of this new guidance will be available at http://www.cms.hhs.gov/Transmittals/ and ultimately incorporated into Appendix PP of the SOM.

QIS Update
