## CMS Update

## Quality and Certification Oversight Reports (QCOR) Website Launch

On August 22, the Centers for Medicare & Medicaid Services (CMS) implemented a new initiative focused on increased transparency and access to data to providers, suppliers, and stakeholders. The QCOR website replaces the Providing Data Quickly (PDQ) system. PDQ provided summarized survey and certification data but PDQ's functionality and ease of access of information to providers and suppliers was limited. CMS therefore removed the requirements for username and passwords for access the data available on the new QCOR website. The QCOR system utilizes a more sophisticated business intelligence platform.

The QCOR website may be accessed directly or through the PDQ link which will redirect to QCOR. This website provides access to results of CMS survey and certification activity over the last 10 years.

### New Nursing Home Survey Process Information

CMS requirements for nursing home participation were revised last year to reflect the substantial advances that have been made over the past several years in the theory and practice of service delivery and safety. The survey protocols and interpretive guidelines serve to clarify and/or explain the intent of the regulations. All surveyors are required to use them in assessing compliance with Federal requirements. The revised nursing home regulations and survey process will be implemented on November 28, 2017.

Nursing home surveys are conducted in accordance with survey protocols and Federal requirements to determine whether a citation of non-compliance appropriate. Indiana long term care surveyors recently participated in a four day webinar based training covering the new survey process and related new federal regulations.

CMS is providing several new resources in preparation for the new survey process. The <a href="Nursing Home">Nursing Home</a> <a href="Downloads">Downloads</a> provides additional information related to Phase 2 implementation including: advance Appendix PP, list of revised F tags, F tags crosswalk, new long term care survey process, long term care entrance conference and provider matrix, and long term care survey pathways.

# Award for Regional Collaborative Project

Each year the Association for Health Facility Survey Agencies (AHFSA) recognizes a state health care quality improvement project for outstanding achievement in education. The ISDH was awarded the 2017 AHFSA Promising Practices Award for Education.

The ISDH Health Care Quality and Regulatory Commission was recognized for its Regional Long Term Care Collaborative Project. Brenda Buroker, Deputy Director for the Division of Long Term Care, accepted the award at the AHFSA Annual Meeting in Orlando and gave a presentation on the project. The Regional Collaborative Project was developed in 2014 in partnership with the University of Indianapolis Center for Aging & Community. Nine regional collaborative groups were created in the state. Each group implements quality improvement projects based on nursing home needs assessments.
