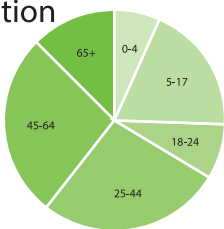


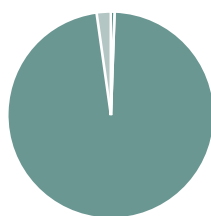

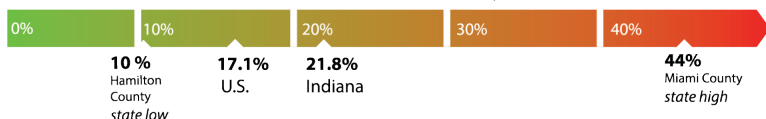

TOBACCO AND HEALTH IN JENNINGS COUNTY

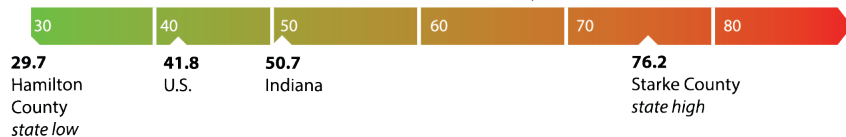
Percent of adults who smoke

33% = 6,993 smokers



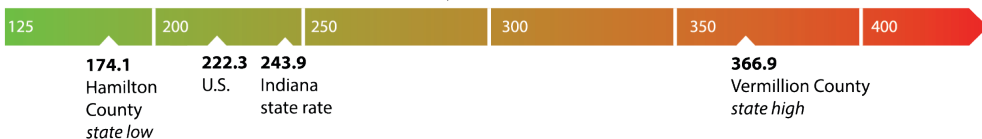
Lung cancer deaths per 100,000 residents

68.8



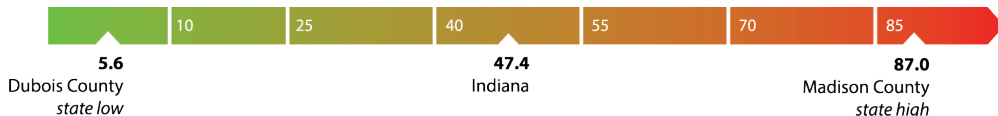
Cardiovascular disease deaths per 100,000 residents

COMMUNITY INDICATORS

Protect and maintain local tobacco control coalition

infrastructure needed to combat tobacco use, as well as working with community organizations to reduce tobacco use among those groups most impacted by tobacco

Decrease adult smoking rates by:

- Promoting the Indiana Tobacco Quitline (1-800-QUITNOW) throughout the community
- Working with healthcare providers to ensure they ask, advise, and refer their patients to tobacco cessation resources
- Supporting employers to create a healthier workforce through providing tobacco employer-sponsored cessation resources to their employees

Decrease youth smoking rates by:

- Supporting community efforts for counter tobacco point-of-sale strategies at the local level

Protect Hoosiers from exposures to secondhand smoke by:

- Supporting local and/or statewide smoke-free air ordinances for worksites, including restaurants, bars, and gaming facilities
- Working toward smoke-free policies in multi-unit housing
