Re: Transitional Intrastate Access Services – 30 Day Filing (Pursuant to 170 IAC 1-6) and Explanation of Compliance with FCC Requirements
FCC Option #1

Dear Secretary:

Enclosed with this letter is a tariff revision for AT&T Communications of Indiana, GP, (AT&T) and TCG Indianapolis (TCG). The enclosed pages for each company show a reduction in each company's terminating access rates as required by the decision of the Federal Communications Commission in its Report and Order and Further Notice of Proposed Rulemaking ("Report and Order") in WC Docket No. 07-135 et al., FCC Release No. 11-161 (Nov. 18, 2011) (FCC Order). The FCC Order adopts a transitional intercarrier compensation framework that reduces terminating intrastate access charges to parity with interstate access rates by July 2013. The instant filing represents the first step in this transitional process and reduces access rates to be equal to ½ of the difference between the Interstate and Intrastate Rates in effect in 2011.

This filing is being made under 170 IAC 1-6 Thirty-Day Administrative Filing Procedures and Guidelines, and is, *inter alia*, allowable per section 3(5) "Changes to rates and charges so long as the change ... results in an overall decrease in revenues..." 170 IAC 1-6-3(5). These revisions do not apply to nor affect any AT&T or TCG retail customers.

Attached are worksheets provided by IURC staff in letter dated May 24, 2012 to all Indiana Local Exchange Carriers entitled "Calculation Worksheets for Transitional Intrastate Access Service, as defined in 47 C.F.R. 51.903(j)". These worksheets have been populated with access rates and actual demand data for AT&T Communications of Indiana, GP and TCG Indianapolis. The sources of the rate and demand data are shown on the Attachment labeled Source Documentation.

In accordance with 170 IAC 1-6-6(b), a notice has been published in the Indianapolis Star on May 30, 2012, its circulation covering the majority of affected AT&T and TCG customers.

PUBLIC NOTICE On November 18, 2011, the Federal Communications Commission ("FCC") released its Report and Order and Further Notice of Proposed Rulemaking ("Report and Order") in WC Docket No. 07-135 et al., adopting a transitional intercarrier compensation framework. In the order, carriers are required to submit to state regulatory commission's data regarding their FY2011 intrastate switched access MOU and rates, broken down into categories and subcategories, and the FCC expects states to monitor implementation of the recovery mechanism and related intrastate tariff filings necessitated by the access reductions. Carriers were ordered to file data and calculations in support of their proposed transitional intrastate access rates scheduled to be available July 1, 2012, as mandated by the FCC's Report and Order. Any wholesale local service provider or interexchange carrier that delivers a call to AT&T Communications of Indiana, GP ("AT&T") and TCG Indianapolis ("TCG") End Users for termination, which originates and terminates within the state (Intrastate calling), will experience a reduction in their current terminating access charges billed by AT&T and TCG. These reductions will be equal to ½ of the difference between the Interstate and Intrastate Rates in effect in Fiscal Year 2011, calculated in accordance with FCC rules. AT&T and TCG's data and calculations and associated tariff sheets will be filed at the Indiana Utility Regulatory Commission ("IURC"), per the FCC Report and Order, on or before May 31, 2012. These tariff revisions will become effective upon the approval of the IURC, but no earlier than July 3, 2012. Any customer may contact the IURC or the Office of Utility Consumer Counselor (OUCC) with a written statement objecting to these applications.
