To Whom It May Concern,

Big River Telephone Company, LLC is submitting our revised Access Tariff No. 2 to be in compliance with FCC Ruling 11-161. This filing is in being made pursuant to 170 IAC-1-6.

Our submission is for a stand-alone intrastate access tariff and is separate from any interstate tariff we may have on file with the FCC. Big River Telephone also states that this tariff complies with the FCC's USF/ICC Transformation Order (*Connect America Fund et al.*, WC Docket No. 10-90 et al., *Report and Order and Further Notice of Proposed Rulemaking* (FCC 11-161, rel. Nov. 18, 2011) [*USF/ICC Transformation Order*]) and other applicable laws.
