Pursuant to Indiana Utility Regulatory Commission ("IURC") IAC 170 1-6-3, and Cause No. 44004, the accompanying tariff material issued on behalf of Craigville Telephone Company, Inc. d/b/a AdamsWells Telecom (the "Company"), bearing Tariff IURC No. 2 (Intrastate Switched Access), and labeled "Original", is being sent to you electronically for filing.

This filing, issued on October 1, 2015, and scheduled to become effective upon IURC approval, consists of original tariff pages containing rates and regulations for intrastate access services. This Competitive Local Exchange Company ("CLEC") IURC tariff mirrors the Company's FCC No. 1 rates and regulations with a few exception notated within the tariff filing.

Note, this tariff is the Craigville CLEC intrastate access tariff. Independent Local Exchange Carrier ("ILEC") intrastate access services in the Craigville exchange will need to be purchased separately, pursuant to the applicable ILEC intrastate access tariff or as otherwise authorized by law. Title Sheet 1 of the filed tariff explains the territory of the ILEC and CLEC as well as the applicable tariff for the ILEC.

REGULATIONS, RATES AND CHARGES

Applying to the provision Intrastate Switched of Access Services within the State of Indiana for connection to intrastate communications facilities for customers within Competitive Local Exchange Company (CLEC) the operating territory of

AdamsWells Telecom.

The CLEC operating territory is the entire state of Indiana, but explicitly excludes the territory of the ILEC affiliate, pursuant to the Certificate of Territorial Authority (CTA) granted by the Indiana Utility Regulatory Commission in Cause No. 44269 (IURC Order issued on Nov. 3, 2004).

Notice: Craigville Telephone Company, Inc. ("Craigville" or "Company") is doing business as (D/B/A) AdamsWells Telecom in Indiana. Craigville operates as both an Independent Local Exchange Carrier ("ILEC") and a Competitive Local Exchange Carrier ("CLEC") in Indiana. The CLEC's authorized territory is the entire state, except for the Craigville ILEC territory; however, Craigville currently operates as a CLEC, for the provision of facilities-based local exchange service, only in the Bluffton exchange of Indiana Bell Telephone Co., Inc., d/b/a AT&T Indiana. The Company operates as an ILEC in the Craigville exchange. This tariff is the Craigville CLEC intrastate access tariff. ILEC intrastate access services in the Craigville exchange will need to be purchased separately, pursuant to the applicable ILEC intrastate access tariff*** or as otherwise authorized by law.

***As of June 17, 2015, Craigville Telephone Company, Inc., concurs (as an ILEC) in the intrastate access tariff of West Point Telephone Co. (TDS), subject to any intrastate exceptions that may be approved by the IURC from time to time.

Access Services are provided by means of wire, fiber optics, radio and any other suitable technology or a combination thereof.
