We demand from all our leaders and from ourselves to leave all fossil fuels in the ground, urgently, and build a 100% renewable, clean energy infrastructure. We want a fossil free world, the only option for solving the climate change crisis in time.

The current draft of the statewide energy analysis does not include any reference to climate change. At minimum, climate change risks should be included and quantified as part of projections, from fuel resources to financials.

Please address the following risks:

1. Stranded assets value of fossil industry operating in Indiana.
2. Legal exposure from other states suing Indiana for pollution drifting.
3. Health and well-being of people living near the four super polluters.
4. Transportation electrification — for instance, electric vehicles and their users' preference for renewable energy.
5. A shift towards decentralized or off-grid renewable electricity generation and use.
6. Economic attractiveness, or lack thereof, of Indiana compared to other MISO states adopting a renewable energy mix — Iowa, for instance.

We ask the Commission to give preference to the scenario of 100% renewable energy by 2030 using the following model's energy mix:

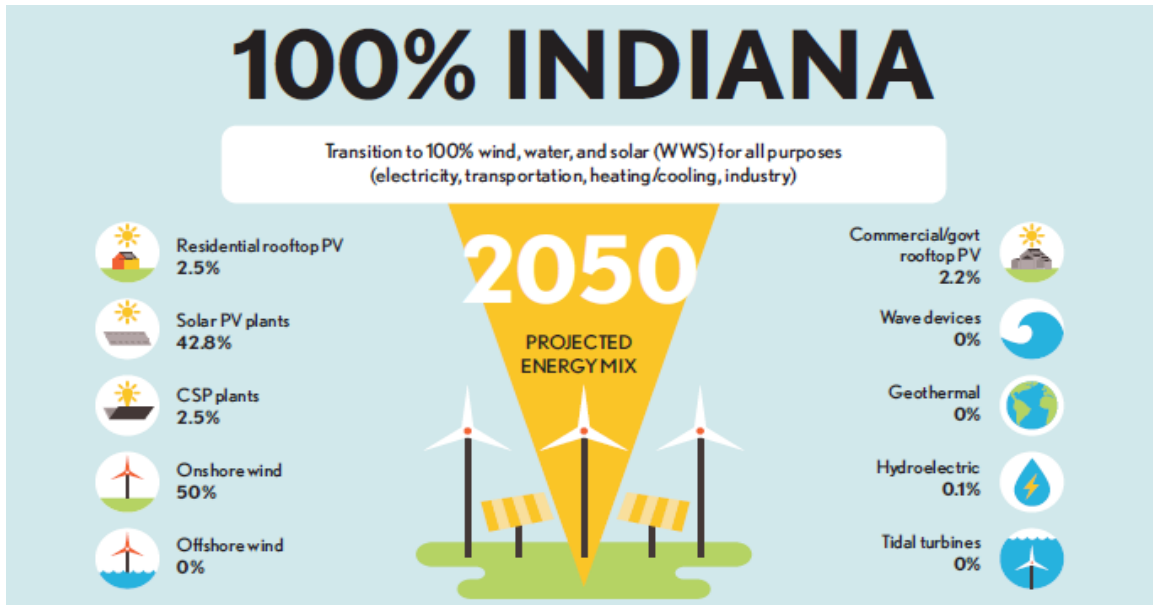
