## Opportunities for Public Comment on AES Indiana's Rate Case

**WHAT:** The Indiana Utility Regulatory Commission (Commission) will hold two field hearings the week of August 18, 2025, in Marion County, to hear from the public on the petition of the Indianapolis Power and Light Company d/b/a AES Indiana under [Cause No. 46258](#).

**WHY:** AES Indiana filed a petition before the Commission requesting approval to increase its rates and charges for electric utility service and approval of certain related relief.

**HOW:** During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the Commissioners and Judge are not allowed to answer questions or engage in any discussion about the case.
