(2) The IURC approved alternative approaches to recover variances in Cause Nos. 43629 GCA 58, 37389 GCA 126, and 37366 GCA 151. The alternative approaches were approved in response to a severe cold weather event that occurred in February 2021 and created high natural gas supplier prices across the country. As such, the alternative variance recovery approach is included in the gas cost adjustment factors for Northern Indiana Public Service Co. (NIPSCO), Citizens Gas of Westfield, and Southern Indiana Gas and Electric Company and will affect the gas costs for a period of 12 or 24 months, as approved in each Cause.
