Opportunity for Public Comment on Indianapolis Power and Light's Certificate of Public Convenience and Necessity Case

What: A field hearing will be held in Indianapolis by the Indiana Utility Regulatory Commission (Commission) to hear from the public on Indianapolis Power and Light's certificate of public convenience and necessity petition, under Cause No. 44794.

When: Sept. 26, 2016, at 6 p.m. EST. Prior to the hearing, the Office of Utility Consumer Counselor (OUCC) will hold an educational session at 5:30 p.m. EST.

Where: Crispus Attucks High School, 1140 Dr. Martin Luther King Jr. Street, Indianapolis, Indiana

Why: Indianapolis Power and Light has filed a petition before the Commission for approval of compliance projects and issuance of certificates that public convenience and necessity will be served by their proposed projects to comply with federally mandated requirements at Indianapolis Power and Light's Petersburg Generating Station and associated cost recovery.

How: During field hearings, ratepayers have the opportunity to speak directly to the Commission or submit written comments. Please note, though, that because this is a pending case, the commissioners and judge are not allowed to answer questions or engage in any discussion about the case.
