Commission to Hold Technical Conference & Prehearing Conference in IPL Investigation

What: The Indiana Utility Regulatory Commission (IURC or Commission) will hold a technical conference and prehearing conference in IURC Cause No. 44602, which is the investigation into Indianapolis Power & Light Company's (IPL) ongoing investment in, and operation and maintenance of, its network facilities. Although the conferences are open to the public, only parties to the case will participate in the discussion.

About the Technical Conference: The IURC will provide its preliminary issues list and set a deadline of April 7, 2015 for parties to submit additional issues for the Commission to consider. IPL will present information regarding the events that occurred on March 16 and 19, and the steps they are taking to maintain public safety. The Commission may ask clarifying questions. IPL will also discuss its responses to questions from the IURC's [March 24, 2015 docket entry](#).

About the Prehearing Conference: Upon conclusion of the technical conference, the presiding officers will discuss further scheduling for this Cause in consolidation with Cause No. 44576. In the event the parties are able to agree on a schedule, that schedule will be formalized on the record during the prehearing conference and preliminary hearing. If no scheduling agreement is reached, the presiding officers may take the parties' proposed schedules under advisement and formalize the schedule at a later date.

The public may provide comments to the Indiana Office of Utility Consumer Counselor (OUCC), the state agency that represents the public before the IURC. The public can submit their comments:
