IURC RM #20-01 LSA #20-84

The Indiana Utility Regulatory Commission (the "Commission" or "IURC"), pursuant to IC 8-1-1-3(g) and 4-22-2.5-2, hereby readopts 170 IAC 1-1.5 regarding ex parte contacts; 170 IAC 1-6 regarding thirty-day administrative filing procedures and guidelines; and 170 IAC 14 regarding small utilities.

A notice of intent was published on March 4, 2020 in the Indiana Register. No requests for any part of this readoption to be separate from this action were submitted in writing within 30 days of this publication. On April 15, 2020, at 10:00 a.m. EDT via conference call a majority of the members of the Commission were present and adopted the foregoing rule.
