Request:	The purpose of this filing is to comply with recent FCC requirements that grandfathered the availability of Section 251/252 UNE transport, analog UNE loops, and resale services. Beginning Jan. 13, UNE transport will no longer be available for purchase from the T-6 tariff; analog UNE loop and resale services will no longer be available from the T-6 tariff after Feb. 2. Beginning Jan. 13 or Feb. 3, respectively, CLECs and resellers must negotiate a commercial agreement with Frontier to purchase those products or services from Frontier. ¹		
	Frontier is also adding FCC Study Area Code numbers (SAC #) to the Title Sheet to clearly designate which Frontier companies are covered under the T-6 tariff ² : "Frontier North Inc. (SAC # 320772 ³ and SAC # 320779 ⁴); and Frontier Midstates Inc. (SAC #323034 ⁵)".		
	Notwithstanding the new federal requirements, this filing is being made as a 30-day filing, as there is no corresponding federal tariff for Frontier to mirror.

² Frontier has been very inconsistent in how it uses the company name "Frontier North, Inc." in its Indiana intrastate tariffs. Sometimes, "Frontier North Inc." refers to just the legacy GTE, sometimes to just the legacy Contel company, and sometimes to both GTE and Contel. Over the last few years, Staff has been working with Frontier to clarify which Frontier companies are affected by various tariffs; the addition of the Study Area Codes to this tariff is part of that effort.

³ SAC # 320772 is the Study Area Code for the old Verizon North Inc., a/k/a GTE North Incorporated (but excluding Contel).

⁴ SAC # 320779 is the Study Area Code for the old Verizon North Inc., a/k/a GTE North Incorporated and Contel of Indiana, Inc.

⁵ SAC # 323034 is the Study Area Code for Contel of the South, which was a separate entity from Contel of Indiana and operated as Verizon North Systems, also known as Alltel Inc. - Indiana.
