## PUBLIC NOTICE

**January 21, 2021**

The Indiana Underground Plant Protection Advisory Committee (“Committee”) will meet on Tuesday, February 9, 2021, at 10:00 a.m. EST. Indiana Governor Eric Holcomb issued Back on Track Indiana guidelines at [www.BackOnTrack.in.gov](http://www.BackOnTrack.in.gov). These guidelines are related to the COVID-19 pandemic and encourage allowing people to work from home and limit travel, where possible, during this time of public health emergency. Accordingly, please note that the Advisory Committee meeting will be conducted electronically via Webex.

If you wish to join the remote meeting, you can participate via phone or electronically. Participants can join up to fifteen minutes in advance (9:45 a.m. EST) to check for connectivity issues and try features like muting and chatting. The meeting will start at 10:00 a.m. EST and no official business shall be conducted prior to that time.

Please note that the Committee has not yet determined whether meetings will be conducted electronically or in person after February 9, 2021. In accordance with Governor Holcomb’s Executive Order 20-09 and extended most recently by Executive Order 20-52, during the public health emergency, Committee meetings will be conducted electronically. Additional 2021 meeting dates are below. There may be periodic adjustments to how these meetings will be conducted during this time and public notices shall be updated accordingly. The Committee will make its determination at least three weeks in advance of the next meeting as to whether that meeting will be held virtually or in-person; this information will be posted online at <https://www.in.gov/iurc/2640.htm> and at the meeting location, if held in-person.
