Request: The utility is requesting to remove its connection charge from its tariff.
Customer Impact: Customers will no longer pay the \$1,635 (3/4") or \$2,028 (1") connection charge. They will instead pay a private contractor the actual cost of installation and the Contractor/Developer Installed Service Charge of \$200 (3/4") or \$230 (1") which is already on Evansville's approved tariff.
