Commission approved a temporary monthly base charge reduction to credit approximately \$3.2 million back to Citizens Wastewater of Westfield, LLC customers. This reduction was made in response to a periodic review conducted by the Commission per Ind. Code Section § 8-1-2-42.5(a). The current 30-Day Filing shows that the \$3.2 million credit will be achieved this September. Accordingly, the utility proposes to eliminate the temporary monthly base charge

reduction.
