Request: I&M is seeking to extend its Economic Development Rider (EDR) by two years. Currently, a customer seeking service under the EDR must submit an application prior to January 1, 2017. I&M is requesting to extend the deadline to January 1, 2019. No other changes to the EDR have been sought in this filing.

The current version of the EDR was approved by the Commission in Cause No. 43953 on February 23, 2011. The Commission subsequently extended it for successive two-year periods through the 30-day filing process. The most recent extension was approved on December 3, 2014 through 30-Day Filing No. 3294.

I&M reports that ten customers have been approved for service under the EDR since the current version was approved in 2011.
