Request: An update to Tariff No. 6 – Residential Electric Service to add a Levelized Billing Program available to customers eligible and have applied for assistance from a home energy assistance program beginning with the first monthly billing cycle after June 30, 2026.

Customer Impact: This tariff update adds language to Rate RS to conform with Ind. Code § 8-1-2-4.7(e), which requires electric utilities to apply a levelized billing plan to all active customer accounts that are eligible and have applied for assistance from a home energy assistance program administered under Ind. Code ch. 4-4-33 to which a levelized billing plan does not apply. Under the terms of the Levelized Billing Program, monthly plan amounts will be reviewed and may be adjusted up to two times per year.
