On June 23, 2022, the Indiana Office of Utility Consumer Counselor (“OUCC”) filed a Verified Petition requesting the Indiana Utility Regulatory Commission (“Commission”) commence an investigation to assess the need for monthly reporting of residential customer arrearage and utility service disconnection data by all jurisdictional Indiana utilities with 8,000 customers or more. The OUCC served a copy of its Verified Petition on all jurisdictional, rate-regulated Indiana utilities with 8,000 customers or more, except for Elkhart Municipal Water Works and Marion Municipal Water Works (collectively, “Respondents”).

On October 17, 2022, the OUCC filed a Motion to Dismiss Upon Settlement Agreements (“Motion”) requesting to voluntarily dismiss its Verified Petition initiating this Cause against all Respondents based on the execution of two settlement agreements with several Respondents, wherein the Respondents agreed to provide certain customer arrearage and disconnection data. No objections to the Motion were filed.

The Commission, having considered the Motion, finds the OUCC’s Motion to Dismiss Upon Settlement Agreements should be granted and this Cause is dismissed.

IT IS THEREFORE ORDERED BY THE INDIANA UTILITY REGULATORY COMMISSION that:

1. The OUCC’s Motion to Dismiss Upon Settlement Agreements is granted and this Cause is dismissed.
2. This Order shall be effective on and after the date of its approval.
