ORDER OF THE COMMISSION

In accordance with Ind. Code ch. 8-1-32.5, the Indiana Utility Regulatory Commission (“Commission”) is authorized to issue a certificate of territorial authority (“CTA”) to communications service providers (“CSP”). Each CSP identified on Attachment A to this Order (“Respondents”) has been issued a CTA.

For the reasons set forth below, the Commission is commencing this investigation to determine whether each Respondents’ CTA should be revoked.

1. Commission Jurisdiction. Respondents are public utilities as defined in Ind. Code § 8-1-2-1(a) and/or CSPs as defined by Ind. Code § 8-1-32.5-4. The Commission has authority to initiate an investigation into all matters relating to any public utility pursuant to Ind. Code § 8-1-2-58. In addition, Ind. Code § 8-1-2-72 authorizes the Commission to alter or amend any order made by the Commission, upon notice and after opportunity to be heard. Inherent in these specific grants of authority is the implicit power to that which is necessary to effectuate the statutory scheme. *S. E. Ind. Nat. Gas v. Ingram*, 617 N.E.2d 943, 948 (Ind. Ct. App. 1993). Therefore, the Commission has jurisdiction over Respondents and the subject matter of this investigation.

2. Background and Scope of Investigation. Ind. Code § 8-1-32.5-6(b)(3)(C) requires a CSP to update information provided in its initial application for a CTA on a regular basis, including its certification from the Indiana Secretary of State showing it is authorized to do business in the state of Indiana. *See* Ind. Code § 8-1-32.5-6(b)(1). Also, a CSP is required by Ind. Code § 8-1-32.5-12 to notify the Commission of changes involving the company or the certificate issued, including changes in ownership or operation, a CSP’s principal business address, or the name of an authorized agent. Consistent with these statutory provisions, each Respondent has been issued a CTA, which includes a requirement for Respondent to notify the Commission of any change involving Respondent or its CTA.

Based upon information from Commission staff, each Respondent has failed to respond to requests for information, can no longer be reached at its principal business address or email, and is no longer authorized by the Indiana Secretary of State to do business in Indiana. Accordingly, the Commission notifies each Respondent that unless it files within 30 days from the date of this Order a request for an evidentiary hearing to demonstrate why it should continue to hold a CTA, the Commission will proceed to issue an Order revoking Respondent's CTA.

IT IS THEREFORE ORDERED BY THE INDIANA UTILITY REGULATORY COMMISSION that:

1. Within 30 days of the date of this Order, if any Respondent believes that its CTA should not be revoked, it shall file under this Cause a request for an evidentiary hearing. Failure to file a request for an evidentiary hearing by a Respondent will result in revocation of its CTA.
2. This Order shall be effective on and after the date of its approval.
