**Request:** An update to Tariff No. 11.5 Optional Rate HLF/LLF Time-Of-Use (“TOU”) Service to clarify language that: (1) customers with an aggregate demand greater than 20 megawatts (“MW”) are ineligible for this TOU rate; (2) HLF customers must demonstrate that Rate LLF would be the most cost-effective rate to receive service or they must be approved by the company; and (3) on-peak periods do not apply to weekends or designated holidays.

**Customer Impact:** This tariff update clarifies language to be more explicit regarding certain requirements and terms of the TOU rate; no rates were updated.
