**Request:** Pursuant to the Commission's November 10, 2020 Order in Cause No.

> 43995-S1, Fountaintown Gas Company, Inc. submits the proposed amended Energy Efficiency Rider ("EER") tariffs for June and July 2023. The proposed June 2023 tariff reduces the May 2023 Rider rate of \$0.83 per month to \$0.27 per month to avoid over refunding. The proposed July 2023 tariff reduces the June 2023 Rider rate from \$0.27 per month to \$0.00 to prevent the utility from issuing refunds beyond

the \$73,414 amount as set forth in the 43995-S1 Order.

**Customer Impact:** The proposed changes impact residential customers by reducing

customer bills by \$0.56 per month effective May 27, 2023, and by \$0.00 per month effective June 27, 2023 and thereafter. This is a reduction from the current charge of \$0.83 per month and will end the

charges for the EER effective June 27, 2023.
