**Filing Party:** **Frontier North, Inc., and Frontier Midstates, Inc. (collectively, “Frontier”)**

**30-Day Filing ID No.:** 50831

**Date Filed:** April 21, 2025; the cover letter was amended on May 19. (These tariff changes became effective May 18 as requested by Frontier. In the absence of this request, the changes would have become effective upon filing. *See*, Ind. Code 8-1-32.5-11(c)) & the Final Order in Cause No. 45733 (Order issued Sept. 14, 2022.)

**Filed Pursuant To:** 170 IAC 1-6 and IURC Cause Nos. 45733.

**Request:** Frontier is requesting approval of an increase in monthly recurring rates for intrastate special access – Voiceband and Digital DS1 facilities. This is a stand-alone intrastate (IURC) access tariff filing that does not mirror, concur in, or adopt any interstate (FCC) access tariff.

**Retail Customer Impact:** Frontier’s intrastate special access services are not offered to the general public or to any residential customers.

**Tariff Page(s) Affected:** Frontier North Inc., Tariff I.U.R.C. No. T-4 (“Facilities for Intrastate Access”): Section 5, Sheet 6.

**Staff Recommendations:** Requirements in 170 IAC 1-6 and in IURC Cause Nos. 45733 were met. Pursuant to IC 8-1-88.6, and as affirmed in Cause No. 45733, the Commission must review the tariff to determine its reasonableness. After performing such a review, **Staff** believes the requested relief to be reasonable and **recommends approval of the tariff submitted as 30-Day Filing # 50831**. The approval date will be the date of the IURC conference at which this 30-day filing is approved through the Utility Articles process.
