Request: In this filing, Duke Energy Indiana, LLC (“DEI”) is seeking authorization to update Rate LED, an unmetered outdoor lighting program. Rate LED is aligned with DEI’s current lighting strategy and is intended to offer customers easily determinable pricing for a suite of modern, efficient LED lighting solutions. LED technology is evolving quickly, and this filing would add products to the product line the Commission approved on December 2, 2020. Furthermore, this filing seeks to update pricing for existing lighting offerings based on 2021 data, updated labor hours per product, and updated useful life assumptions for certain products.

Customer Impact: Under Rate LED, customers are responsible for paying a volumetric Energy charge of \$0.073298 and fixed monthly charges for the lighting Fixtures, Poles, and Maintenance. Each of DEI’s new or updated proposed rate components under Rate LED can be found below.¹
