Request: NIPSCO is proposing a revision to Rider 685, Plug-In Electric Vehicle Off-Peak Charging Rider (Pilot Program) to extend the program for a period of two (2) additional years. The Commission originally approved Rider 685 on February 9, 2012 in Cause No. 44016 for a period of two (2) years; set to expire January 31, 2015.

The incentive of up to \$1,650 per customer to be used toward the purchase and installation of a plug-in electric vehicle (PEV) charging station at the customer's residence will continue during the extended period of two years or until such time as the funds set out in Rider 685 are exhausted, whichever occurs earlier.

Customer Impact: The extension impacts Residential Customers concurrently served under Rate 611 or Rate 612 (the normal residential rates) but who also avail themselves to be billed for charging their PEVs under Rider 685. Rider 685 is exclusively for charging of such Customers' licensed PEVs using electricity provided by the company at the Customer's premises within the Company's service territory.

Staff Recommendations: This Pilot Program was originally approved in Cause No. 44016 with an expiration date of January 31, 2015 and limited to the first 250 customers who signed up for it. Also approved was the company's budget for funds to be able to offer an incentive of up to \$1,650 per customer to help with the purchase and installation of the necessary equipment at the customer's residence for charging their PEVs. NIPSCO has not yet reached the maximum number of eligible customers nor exhausted the funds available for this Rider. NIPSCO wishes to extend the expiration date for Rider 685 to January 31, 2017 as well as continue to offer the incentive until they exhaust the original budgeted funds for the incentive or January 31, 2017, whichever comes first.

Staff's review of this filing finds that it comports with the rules for such filings and recommends approval of this request.
