CERTIFICATION OF ELIGIBILITY FOR SENIOR JUDGE STATUS FOR 2020

I AM AN APPLICANT FOR CERTIFICATION BY THE INDIANA JUDICIAL NOMINATING COMMISSION AS A SENIOR JUDGE FOR 2020. IN SUPPORT OF MY APPLICATION, I CERTIFY AS FOLLOWS:

1. I served as an elected or appointed judge, magistrate, or commissioner appointed under I.C. 33-33-49 for at least 4 years. Yes No N/A
2. At least one year of my four years of service was in 2015 or a subsequent year. Yes No N/A

If certified, I agree to continue to serve as a special judge in any cases in which I now serve as special judge, provided that if the circumstances that led to my appointment as special judge no longer exist, and no other disqualification exists, the case may be returned to the regular judge of the court where the case is pending. Further, I understand that I will receive senior judge credit for serving in special judge cases that were assigned to me at the time I left office.
12. If certified, I agree to not practice law in any court in which I am appointed or assigned or in which I serve as a Senior Judge.
13. I certify that I am fit to serve as a Senior Judge.
