



<u>Risk Assessment</u> – All defendants in the target population are assessed for pretrial risk using the Indiana Risk Assessment System – Pretrial Assessment Tool (IRAS-PAT). The IRAS-PAT measures a person's likelihood of failing to appear in court or being arrested during the pretrial phase of a defendant's criminal case. Defendants are assessed after arrest while in custody or after release from jail, but before an initial hearing or meaningful first appearance.

Telephonic Notification: Defendant will only receive telephone and text court reminders. No face-to-face appointments.


Monitoring Level 1 (Low): At least one face-to-face appointment with a pretrial case manager every month.

Monitoring Level 2 (Moderate): At least one (1) face-to-face appointment AND one other form of contact with a pretrial case manager every month.

Monitoring Level 3 (High): At least two (2) face-to-face appointments with a pretrial case manager every month.


Each monitoring level shall receive telephonic notifications, monthly criminal record checks, and additional release conditions if ordered by a court. Additional release conditions may include, but are not limited to: kiosk reporting; day reporting; home/work contacts by a case manager; electronically monitored curfew, exclusion zones, or alcohol testing; home detention; and drug testing.






<u>Financial Bail Requirements</u> – Each arrested defendant is subject to a bail schedule developed by the Monroe Circuit Court Board of Judges, a copy of which can be found in the Local Rules for the Monroe Circuit Court. If permitted by the bail schedule, a defendant may be released on their own recognizance or permitted to post a financial bail prior to an initial hearing in the case. The chart below indicates financial bail requirements imposed on a defendant at the conclusion of their initial hearing. Greater detailed data collection in this area began in the first quarter of 2017.



The following chart shows the financial bail requirements by offense type after the initial hearing. The percentage shown in the labels of each column indicates the percentage of defendants in each offense type category.



The following chart indicates the risk level of defendants by the established financial bail requirements after the initial hearing. The percentage shown in the labels of each column indicates the percentage of defendants in each financial bail requirement category.



<u>Appearance Rate</u> – The appearance rate for released defendants can be calculated in multiple ways. One way is to track the defendant's appearance at each pretrial hearing and calculate the rate by the total number of pretrial hearings. Alternatively, an appearance rate can be calculated by the percentage of defendants who attend all scheduled hearings during the pretrial stage. The figure below illustrates an example calculation of each method.






The next chart shows the appearance rate by defendant by case type. The percentage listed in each column indicates the percentage of the overall number of defendants categorized in the column.


















