- Call Meeting to Order
 - Nick Schenkel called meeting to order at 1.02 PM
- Approval of Agenda
 - Approved by acclamation.
- Approval of Minutes
 - Cheryl Wright, motion; 2nd Wendy Knapp; unanimously approved by roll call vote.
- State Library Report
 - Evergreen update
 - Putnam County Public Library went live just before COVID-19 shutdown; Fortville-Vernon Township Public Library will likely go live in first weeks of May; ISL is actively talking with 3 other public libraries interested in Evergreen migrations this year.
 - COVID-19 response included reduction in resource sharing and extension of due dates.
 - INSPIRE update
 - RFP (23 April was deadline for bidder responses)

- Jake Speer discussed INSPIRE as continued funding priority with COVID-19 budget-related challenges.
- Usage statistics were discussed; March decline likely related to school's moving to remote teaching in response to statewide shutdown.
- InfoExpress update
 - Services suspended at least through 1 May; 75% of libraries in Indiana had already suspended service when InfoExpress closed.
 - ISL anticipates a 1 May renewal, maintaining or reducing current costs.
 - ISL will provide guidelines related to post-COVID-19 reopening and processing of interlibrary loan materials.
- IN-SHARE update
 - COVID-19 responses included cancellation of loan requests; libraries were not billed for requests. Copy requests were still allowable.
 - ISL has no plans to move forward with increase to IN-SHARE costs at present.
- SRCS update
 - SRCS sharing ceased with shutdown of InfoExpress.
 - ISL is working on updated master list of SRCS participants.
 - No movement on API for academics.
 - Nicole Brock will post a list of all libraries that have submitted their SRCS membership agreements and update weekly.
 - Reshare in testing phase (alpha testing in 3 libraries); roadmap shows beta release on 30 April.

RESHARE in testing phase. Alpha testing 3 libraries; roadmap shows beta on 30 April. Product development is continuing through remote work with an anticipated release of 1.0 on 31 July 2020.

- Old Business
 - Committee Membership
 - Need to add a K-12 school librarian to committee.

- Discovery to Delivery—D2D was planned for 5 June, but planners are considering postponement with the possibility of some sort of programming for ILL librarians and staff in the fall.
- New Business
 - Return anywhere—ISL is working to coordinate guidelines for a “return anywhere” arrangement for patrons to return ILL materials to their local libraries for shipment. Guidelines may be endorsed by ALI and PALNI.
