I. Call Meeting to Order

II. Approval of Agenda

III. Approval of Minutes

IV. State Library Report

a. Evergreen update

- No significant change in stats since last meeting.
- Two new servers have arrived and will be brought online on Labor Day. Complete database must be copied.
- Upcoming annual conference in August.

b. INSPIRE update

- INSPIRE Advisory Committee, parallels work with ISL RSC.
- J. Petrusa is joining the RSC committee.
- Remaining members of the Advisory Committee will be invited to join as well.
- There is no statutory mandate to have an Advisory Committee. ISL can create an ad hoc committee of RSC to do INSPIRE RFP and will work to have school library representation.

Motion to invite members of Advisory Committee: M. Paxton; 2nd A. Davis; approved unanimously.

- No change in INSPIRE stats (July numbers haven't been added).
 - N. Brock met with EBSCO to better understand what stats mean (sessions and searches).
 - Gale content may've been part of the decline.
 - EBSCO thinks it has to do with EBSCO Discovery Service API profile, specifically from IU Bloomington; however, that still doesn't account for all of the declines.
 - EDS counts a search in one database as a search in all of the databases. EBSCO is using COUNTER5. Profiles are specific to institutions, so an adjustment to search boxes can distort statistics.
 - Sessions and full-text downloads may be the most reliable metrics, and continuing to report statistics per usual may continue to make sense. A report can be run that shows what's coming from EDS and what's not.
 - c. InfoExpress update
 - N. Brock met with NowCourier in July.
 - Challenges still exist for holiday delivery schedules.
 - New team managing ISL account.
 - Not sure about timeline for technical upgrades.
 - New warehouse manager, making things easier for drivers. Still working on training new hires on the needs and expectations of libraries.
 - Statistics indicate a return to a more normal pattern of ILL transport this year.
 - d. IN-SHARE update
 - No report.

 - There has been a Chrome upgrade that broke some features. Those are now fixed.
 - Reduced statistics may be related to slow recovery of public libraries.
 - Coming media mail increases may encourage more use of courier services.
