Mary Cleason Brady O'Hair was born June 10, 1885, to Cleason Calvin and Florence (Moore) Brady. She spent over 50 years researching her family history, often with the help of her daughter, Mary Louise (O'Hair) Sator. O'Hair also served as curator of the Wabash County Museum for eighteen years. She died in May 1979.
