# Technical Guide for Library Redistricting

## Introduction

This guide is for use in determining library district population totals following the decennial census.

The decennial census is an actual count of a geographic area and not just an estimate, which is why we wait for the redistricting data (PL 94-171) to be released following the decennial census in order to determine official library district population numbers.

The guide lists geographic areas covered by each library district in Indiana, by district and by county, denoting whether the area is covered by tax or by contract, as of the end of the 2020 Census redistricting period (September 2023).

Libraries make changes to district boundaries and coverage areas throughout the decade by contacting the Indiana State Library's Library Development Office (LDO). Any changes between each decennial census must be noted on the LDO **TABLE 1** so calculations of population totals remain accurate.

Before beginning library redistricting work, check with the LDO to update any changes to district boundaries beyond what is in the current version of Table 1 or in this 2023 guide.

Once the **2030 Census PL 94-171** redistricting data has been released, access current data for geographic areas using the Census Bureau's data tool, Data.Census.gov.

You can use this guide along with **Table 1** and the most current versions of Indiana township maps (<u>StatsIndiana</u>) and 2030 Census tract and block maps (<u>Census Bureau</u>), which are released with the **PL 94-171** data, to complete your work.

Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Elkhart in Baugo Township).

Add these four population numbers to complete the total for this district.

Enter your work in **Table 1**.

#### **Garrett Public Library** (DeKalb County)

This library district is composed of Butler Township and the balance of Keyser Twp by tax. It does not include the part of Auburn in Keyser Township, which is served by the Eckhart Public Library. See the current township map for DeKalb County. <a href="https://www.stats.indiana.edu/maptools/boundary.asp">https://www.stats.indiana.edu/maptools/boundary.asp</a>

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for Butler Township and Keyser Township. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Auburn in Keyser Township).

Add the two townships. Subtract the population for the part of Auburn in Keyser Township.

#### Hartford City Public Library (Blackford County)

This library district is composed of Hartford City (covered by tax), the balance of Licking Township (covered by contract), Washington Township (by contract), and Jackson Township (by contract) excluding the part of Dunkirk in the township, which is served by Dunkirk Public Library.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Dunkirk in Jackson Township).

Add Licking, Jackson, and Washington Townships. Subtract the population for the part of Dunkirk in Jackson Township.

See **Table 1** for details on calculating population served by tax versus population served by contract. Enter your work in **Table 1**.

#### **Jay County Public Library**

This library district is composed of ten full townships (covered by tax): Bearcreek Twp, Greene Twp, Jackson Twp, Jefferson Twp, Knox Twp, Madison Twp, Noble Twp, Pike Twp, Wabash Twp, and Wayne Twp. The district also covers Richland Township by tax, excluding the part of Dunkirk in the township, which is covered by the Dunkirk Public Library district. **To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the full townships. Add the ten townships. Subtract the population of the part of Dunkirk in Richland Township. Enter your work in **Table 1**.

#### **Kendallville Public Library** (Noble County)

This library district is composed of two full townships (covered by tax): Orange Twp and Wayne Twp. It also covers the part of Kendallville in Allen Township by tax. See the current township map for Noble County.

Enter your work in **Table 1**.

#### **Knox County Public Library**

This library district is composed of eight full townships (covered by tax): Busseron Twp, Decker Twp, Harrison Twp, Johnson Twp, Palmyra Twp, Steen Twp, Vincennes Twp, and Widner Twp. The district also covers Washington Township by tax, except the part of Bicknell in the township, which is served by Bicknell-Vigo Township Public Library.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the full townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Bicknell in Washington Township).

Add the nine townships. Subtract the population of the part of Bicknell in Washington Township.

#### **LaPorte County Public Library**

This library district is composed of sixteen full townships (covered by tax): Center Twp, Clinton Twp, Galena Twp, Hanna Twp, Hudson Twp, Johnson Twp, Kankakee Twp, Lincoln Twp, Noble Twp, Pleasant Twp, Prairie Twp, Scopio Twp, Springfield Twp, Union Twp, Washington Twp, and Wills Twp. The district also covers Coolspring Township except by tax except parts of Michigan City and Trail Creek in the township, which are served by Michigan City Public Library.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the full townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the parts of Michigan City and Trail Creek in Coolspring Township).

Add the seventeen townships. Subtract the population of the parts of Michigan City and Trail Creek in Coolspring Township.

Enter your work in **Table 1**.

#### Marion Public Library (Grant County)

This library district is composed of the city of Marion, but excludes the part of Marion in Mill Township.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the city of Marion. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Marion in Mill Township).

Subtract the population of the part of Marion in Mill Township from the population of the city of Marion.

#### Michigan City Public Library (La Porte County)

This library district is composed of Michigan Township (by tax), the part of Michigan City in Coolspring Township (by tax), and the part of Trail Creek in Coolspring Township (by tax).

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for Michigan Township. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the parts of Michigan City and Trail Creek in Coolspring Township).

Add the population of the parts of Michigan City and Trail Creek in Coolspring Township to the population of Michigan Township.

Enter your work in Table 1.

#### Montezuma Public Library (Parke County)

This library district is composed of Reserve Township (by tax) and the part of Montezuma in Wabash Township (by tax).

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for Reserve Township. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Montezuma in Wabash Township).

Add Reserve Township and the part of Montezuma in Wabash Township.

#### **New Castle-Henry County Public Library**

This library district is composed of ten full townships (covered by tax): Blue River, Dudley, Franklin, Greensboro, Harrison, Henry, Jefferson, Liberty, Prairie, and Stoney Creek. The district also covers Wayne Township by tax, except Knightstown, which is covered by Knightstown Public Library.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the full townships and Knightstown.

Add the eleven townships. Subtract the population of the Knightstown.

Enter your work in **Table 1**.

#### **Noble County Public Library**

This library district is composed of nine full townships (covered by tax): Albion, Elkhart, Green, Jefferson, Noble, Sparta, Swan, Washington, and York. The district also covers Allen Township by tax, except the part of Kendallville in the township, which is covered by Kendallville Public Library.

**To calculate the population total for the district,** use the redistricting data (PL 94-171) for the full townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Kendallville in Allen Township)

Add the ten townships. Subtract the population of the part of Kendallville in Allen Township.

#### **North Madison County Public Library System**

This library district is composed of four full townships (covered by tax): Boone, Duck Creek, Pipe Creek, and Van Buren. The district also covers Lafayette Township by tax, except the part of Anderson in the township, which is covered by Anderson Public Library.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the full townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Anderson in Lafayette Township).

Add the five townships. Subtract the population of Anderson in Lafayette Township.

Enter your work in **Table 1**.

#### Otterbein Public Library (Benton County)

This library district is composed of Bolivar Township (Benton Co) by tax, Medina Township (Warren Co) by contract, and the part of Otterbein in Shelby Township (Tippecanoe Co) by tax.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for Bolivar and Medina Townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Otterbein in Shelby Township, Tippecanoe County).

Add the two townships to the population of the part of Otterbein in Shelby Township, Tippecanoe County. See **Table 1** for details on calculating population served by tax versus population served by contract.

#### **Parke County Public Library**

This library district is composed of eleven full townships (covered by tax): Adams, Florida, Greene, Howard, Jackson, Liberty, Penn, Raccoon, Sugar Creek, Union, and Washington. The district also includes Wabash Township, except the part of Montezuma in the township, which is covered by Montezuma Public Library.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the full townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Montezuma in Wabash Township).

Add the twelve townships. Subtract the population of part of Montezuma in Wabash Township.

Enter your work in **Table 1**.

#### **Pendleton Community Public Library** (Madison County)

This library district is composed of Fall Creek Township and Green Township, both by tax. The district also includes Adams Township by tax, except the part of Anderson in the township, which is covered by Anderson Public Library district.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the full townships. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Anderson in Adams Township).

Add the three townships. Subtract the population of the part of Anderson in Adams Township.

#### **Tippecanoe County Public Library**

This library district is composed of Tippecanoe County except the parts of the county covered by Otterbein Public Library and West Lafayette Public Library.

Otterbein Public Library covers the part of Otterbein in Shelby Township. West Lafayette Public Library covers the city of West Lafayette.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the county and for West Lafayette. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Otterbein in Shelby Township).

Subtract the population of West Lafayette from the population of Tippecanoe County. Subtract the population of the part of Otterbein in Shelby Township.

**Upland Public Library** (formerly Barton Rees Pogue Memorial Public Library) (Grant County)

This library district is composed of the town of Upland (covered by tax), the balance of Jefferson Township (covered by contract). The district includes Monroe Township (covered by contract). The district does not include part of Matthews in Jefferson Township, which is covered by Matthews Public Library. **To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the totals of Jefferson Township and Monroe Township. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Matthews in Jefferson Township).

Add the two townships. Subtract the population of the part Matthews in Jefferson Township.

See Table 1 for details on calculating population served by tax versus population served by contract.

Enter your work in **Table 1**.

#### Warsaw Community Public Library (Kosciusko County)

This library district is composed of Wayne Township and part of Warsaw in Plain Township.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the township. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Warsaw in Plain Township).

Add these two population numbers to complete the total for this district.

#### Waterloo-Grant Township Public Library (DeKalb County)

This library district is composed of Grant Township, the part of Waterloo in Smithfield Township.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the township. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (the part of Waterloo in Smithfield Township).

Add these two population numbers to complete the population total this district covers by tax. The remainder of Smithfield Township is covered by contract.

Enter your work in **Table 1**.

#### **Wells County Public Library**

This library district is composed of the county, except the parts of Markle in Rockcreek and Union Townships.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for the county. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (parts of Markle in Rockcreek and Union Townships).

Subtract the population of parts of Markle in Rockcreek and Union Townships from the population of Wells County.

#### Hussey-Mayfield Memorial Public Library, Lebanon Public Library, and Thorntown Public Library (Boone County)

#### **Hussey-Mayfield Memorial Public Library**

As of 2022, this library district covers Zionsville, which has newly zoned boundaries. The district covers areas which were previously Eagle and Union Townships by tax, so the library district boundaries follow along the old township lines in some areas. The district also covers what is now Worth Township by tax. The district covers what is now Perry Township and the new municipal boundaries of Whitestown and the remainder of Zionsville by contract.

#### **Lebanon Public Library**

As of 2025, this library district is composed of Center Township (covered by tax) and three townships covered by contract: Clinton, Harrison, and Perry.

#### **Thorntown Public Library**

As of 2025, this library district is composed of three townships (by tax): Jefferson, Sugar Creek, and Washington.

**To calculate the population total for Hussey-Mayfield district,** use the redistricting data (PL 94-171) at the census block level. Using GIS is necessary to get an accurate population count for this district.

For the 2020 Census library redistricting process, the State Geographic Information Office (GIO) assisted us. Once we completed library district boundaries for the **Library District Interactive Map** with the IBRC, we shared shape files with the GIO. The GIO created an ArcGIS map for Boone County, layered it using 2020 Census blocks, and ran the population figures. We were able to compare their numbers to our hand count method where we used the 2020 Census block maps in print.

#### Muncie-Center Township Public Library and Yorktown Public Library (Delaware County)

#### **Muncie-Center Township Public Library**

This library district is composed of Center Township and four parts of Muncie in surrounding townships and areas: Hamilton Twp, Harrison Twp, Liberty Twp, and parts of Muncie in Census Tracts 24.01 and 24.04 in Yorktown (all by tax). In 2013, Mt. Pleasant Township and Yorktown consolidated into the new Town of Yorktown.

See <u>Yorktown/Mt. Pleasant Township Consolidation</u>. Yorktown Public Library serves the newly consolidated Town of Yorktown, except for the area of Yorktown annexed by Muncie. These annexed areas consist of the following 2020 Census blocks: 2001, 2002, 2003, 2013, and 2014 within 2020 Census Tract 24.01 and 2022 within Census Tract 24.04. For 2030 redistricting, view the current 2030 Census block maps to identify the current tracts and blocks that make up these parts of Muncie within Yorktown. Consult with the Indiana GIO to create correct maps.

To calculate the population total for Muncie-Center Township Public Library, use the redistricting data (<u>PL 94-171</u>) for Center Township. Use block-level redistricting data for the blocks in Yorktown that are annexed by Muncie. Then, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (parts of Muncie in Hamilton, Harrison, and Liberty Townships).

Add Center Township to the parts of Muncie in the three townships and include the total population from the blocks that make up the parts of Muncie in Yorktown. Enter your work in **Table 1**.

#### **Yorktown Public Library**

This library district is composed of Yorktown (formerly Mount Pleasant Township) by tax, except the area of Yorktown annexed by Muncie in Census Tract 24.01 and 24.04.

**To calculate the population total for the district,** use the redistricting data (<u>PL 94-171</u>) for Yorktown. Subtract the population (above) of the blocks that make up the parts of Muncie in Yorktown. **Enter your work in Table 1**.

#### Milford Public Library and Nappanee Public Library (Elkhart and Kosciusko Counties)

The Milford Public Library district is composed of Van Buren Township (Kosciusko County) and the eastern half of Jefferson Township (Kosciusko County), both covered by tax.

The Nappanee Public Library is composed of the part of Nappanee in Locke Township (Elkhart Co) and the western half of Jefferson Township (Kosciusko County), both covered by tax.

The library district boundary map that splits Jefferson Township is in the shared drive:

LDO >> 2020 Census Library Redistricting File >> Milford PL-Nappannee PL.

To calculate the population totals for the districts by hand, use the redistricting data (PL 94-171) for each block total within Jefferson Township. See the 2030 Census block maps from the Census Bureau for Jefferson Township, Kosciusko County to determine the 2030 Census tracts and blocks that will be used to divide the township's blocks between Milford Public Library (eastern half) & Nappanee Public Library (western half) according to the library district boundary map.

Files from the previous years can give you the 2010 and 2020 census tract and block numbers that were used. This can help you determine which 2030 tracts and blocks to choose on the map. Use the boundary map with the block maps to select the blocks you need, pull the redistricting data, and add up 1) the Jefferson Township blocks for Milford Public Library and 2) the Jefferson Township blocks for Nappanee Public Library.

For Milford PL's total, use the redistricting data (PL 94-171) for Van Buren Township. Add this to the census block total for the eastern half of Jefferson Township. Enter the total population in **Table 1**.

For Nappanee PL's total, you must wait until the Census Bureau releases the next iteration of census data to access the population data on partial geographies (part of Nappanee in Locke Township). Add this to the block total for the western half of Jefferson Township. Enter the total population in **Table 1**.
