## PDO Answers Several LEU FAQ's for Certified Public Librarians

This is your 2nd installment of 2013 Certification Reminders in the Wednesday Word. This week's topic is Library Education Units.

All certified library professionals need to take advantage of the many professional development opportunities available to them for LEU credit. Professional development helps us better serve our communities and is an important part of the growth of librarianship!

#### How many LEUs do I need?

- Professional Assistants need a minimum 50 LEUs, at least 10 of which must be TLEUs.
- Branch Heads & Department Heads need a minimum 75 LEUs, (minimum 10 TLEUs). -Directors need a minimum 100 LEUs, (minimum 10 TLEUs).

The requirement of "at least 10 TLEUs" means you can have as many TLEUs as you want, so long as you have at least 10. TLEUs in excess of 10 still count toward your overall total.

**IMPORTANT:** The dates of your LEUs must fall between the date your 5-year license was issued and when it expires. LEUs accumulated prior to the date your license was issued cannot be included in your required total. If you don't know exactly when your certificate was issued you can search for your license on the Professional Licensing Agency website.

What happens if I haven't completed my LEUs? LEUs are a requirement for keeping your certificate in good standing which is tied to state standards. State standards are tied to your library's funding.

#### Students Encouraged to Promote Summer Reading via Video Challenge

CSLP Teen Video Challenge

The Indiana State Library is challenging Indiana students to create a video promoting Summer Reading at the Library. The national initiative is part of the Collaborative Summer Reading Program and will award \$275 to winners in each state and earn an award for their library.

The video should be a short, yet imaginative, public service announcement and must produced by an Indiana student or group of students. The video that best encourages use of their local public libraries and promotes reading all summer

long will take away the contest prize and be featured throughout 2011 as the official commercial for Indiana's Summer Reading Program.

## **LSTA Grant Applications** Accepted through March 15
