Starting with the small floor cooler unit we will be switching out the pans in the top daily even when not in use. The bottom floor will be cleaned daily with the doors, handles, and all the way around it.
I have soaked and scrubbed the cannopans and will ensure that it be cleaned and sanitized after use. We have cleaned the wall and racks all around the dish area and soda machine which should help with the knots.
We are also working with a new pest company to help with the knots.
