# Nursing- Seleah Settle - Report Mailed

- **a.** Full Time Nursing Position
  - I. Seleah stated that she has not received any more applications for the open nursing position due to the salary. The salary is dictated by County Council. The job ab is being posted in the Democrat.
  - II. Cindy Rose suggested reaching out to the older generation of retired nurses to see if anyone would be interested. Cathy Rountree recommended being in contact with local college's nursing programs so they can inform recent graduates of job openings or interning opportunities. Thomi inquired if it would be feasible to replace the full-time position for 2 part time positions. Seleah said she would continue to explore all these options.

# **b.** Senior Nursing Clinics

- I. Cathy stated that she loves the wellness check up clinic the nurses do at Hickory Ridge and wondered if they could perform something similar on a larger scale at the office.
- II. Seleah said that it has been discussed. The nurses have explored holding a clinic at the surrounding senior apartments, but with COVID constantly fluctuating it is hard to cement any plans. Seleah has also been in contact with the director for the Veteran Affairs Office, Chris Snell, discussing the services the department can offer veterans. Seleah does hope to be able to do more senior and veteran outreach in the future.
- c. Naloxone
  - I. Cindy Rose inquired\* if the citizens that receive Naloxone are given training on how to administer it. Seleah said each Naloxone kit comes with instructions, and several other educational materials regarding treatment. She also gives them general instructions verbally whenever they pick up the kits.
  - II. Seleah specified that almost all the Naloxone that is given from the health department is for distribution sites. To be a distribution site that entity must go through some basic training through the state and get approved in the state's system. Most of the Naloxone is given to Centerstone, Nashville Police, the Sheriff's Department, volunteer fire departments, and other community services.

- **a.** Sewer Progress
  - I. Linda Bauer stated that lately realtors have been putting in their Lake Lemon home listings that sewer will be available in 5 years, and she wanted to know if this was true.
  - II. Ernie said that the department is not involved with the Regional Sewer District. He has frequent correspondence with members of the Helmsburg Sewer District, and from his understanding things are moving forward with the sewer expansion in the Helmsburg and Lake Lemon area. An architect has been hired and designs are still being drafted. The completed plans must be approved by IDEM. Once the expansion is approved, Ernie believes it may take longer than 5 years for everything to come to fruition.

  - I. Thomi said she would like to revisit getting a group of pertinent community entities together to discuss the open burning issues within the county.
