- a. Mobile Clinic
 - I. Cathy Rountree inquired about the mobile clinic discussed in Corey's report. Corey Frost said that the state has a mobile unit that travels within district 8 performing vaccinations. They visit the EMS base roughly once a month.
- b. Solar Eclipse Day-April 8th, 2024
 - II. Corey stated they are preparing for the solar eclipse. The county offices and schools will be closed that day to reduce traffic. A planning meeting took place on Monday, January 22nd with the town and other crucial community members to discuss a property owner wanting to place up to 40 food trucks on their property in town.
