## STEPS TO GET A SEPTIC PERMIT

1. Obtain a soil report of the area of the proposed septic system (Information Attached).
  - a. Select a soil scientist. A list of soil scientists who do a lot of work in Carroll County is attached.
    - i. These soil scientists are knowledgeable in the geology of Carroll County and will be able to assist you in the selection of a location on your property that is likely to work well for a septic system.
    - ii. The soil scientist will submit a copy of the results of the soil tests to the Carroll County Health Department.
2. The Health Department will provide a specification sheet after receiving the soil reports and send it to you and your contractor if you have already selected one.
3. The contractor will submit the application with a drawing of proposed system to the Health Department.
4. The information will be reviewed by the Health Department.
  - a. Any alterations required to be in compliance with the Residential On-Site Sewage System Rule 410 IAC 6-3-8 will be discussed with the contractor and the plan will be revised as necessary
5. Pay Fee:
  - a. Septic system repair - \$ 75.00.
  - b. New Septic System - \$ 100.00.
6. System approved and a permit will be issued.

## ADDITIONAL INFORMATION

OBTAIN A SOIL EVALUATION FROM A CERTIFIED SOIL SCIENTIST--A LIST IS AVAILABLE FROM THE HEALTH DEPARTMENT [attached].

UPON RECEIPT, THE HEALTH DEPARTMENT SANITARIAN WILL EVALUATE THE PERMEABILITY OF THE SOIL, DETERMINE THE REQUIRED SQUARE FOOTAGE OF THE ABSORPTION FIELD BASED ON THE NUMBER OF BEDROOMS, TRENCH DEPTH, AND PERIMETER DRAIN REQUIREMENTS AND DEVELOP A MINIMUM SPECIFICATION FOR YOUR NEW SYSTEM.

DEVELOP A PLAT PLAN TO SHOW THE LOCATION OF THE RESIDENCE, RESIDENCE WELL, DRIVEWAY, OTHER BUILDINGS, PROPERTY LINES, AND THE PROPOSED LOCATION OF THE SEWAGE SYSTEM. THE SYSTEM SHOULD BE LOCATED IN THE VICINITY OF THE SELECTED SOIL BORING AND THE AREA STAKED OUT TO PREVENT CONSTRUCTION TRAFFIC FROM COMPACTING THE SOIL.

SELECT AN INSTALLATION CONTRACTOR WHO, UTILIZING THE PLAT PLAN , WILL DEVELOP A SYSTEM DESIGN THAT WILL SHOW THE LOCATION OF BENCHMARK, SPOT ELEVATIONS AND LAND CONTOURS, SLOPE OF ABSORPTION FIELD SITE, LOCATION OF ALL SOIL BORINGS, LOCATION AND ELEVATION OF ALL SYSTEMS COMPONENTS. THE HOMEOWNER/CONTRACTOR WILL SUBMIT THE PLAT PLAN, APPLICATION, AND SYSTEM DESIGN ALONG WITH THE FEE TO THE HEALTH DEPT FOR REVIEW AND APPROVAL/ DISAPPROVAL. IF APPROVED, THE HEALTH DEPARTMENT WILL ISSUE A PERMIT.
