NURSING DIVISION REPORT

We are still working on getting all the school aged children up to date of their vaccines. The students have to have all required vaccines by the date determined by the school corporation. If not, the student will be excluded from school until they have been administered.

Also, September is the start of our flu clinic season and we already have 4 clinics scheduled. We offer three different types of flu shots. The three types are:

Regular dose (6 months to 49 yrs old) \$35.75

FluBlock (50-64 yrs old) \$69.84

High Dose (65 yrs +) \$69.84

We also have VFC and 317 flu shots available. These flu shots are provided by the state for individuals on Medicaid or have no insurance coverage.

ENVIRONMENTAL DIVISION REPORT

We have had 2 septic systems put in by the same installer with uncertified staff, due to this; one of the systems cannot be used. This has left the homeowner with very little property to put another system in. We are working with the State and have visited this site 8 times to measure and investigate the problems.

The second septic site will also need to be investigated and probably parts of the system dug up as well. This will start after our IEHA Conference. One of the people putting in the system signed off the permit. We were never informed the system had been started, and no call for a final. This has been turned over to the Prosecutor. We will be working with the state also on this second site.

We have performed 22 septic inspections.

We have been working on the test for installers to take and the requirements for certification through the Health Dept.

VITAL RECORDS REPORT

In August there were a total of 42 deaths with 22 being premature. (Before the age of 75). I have included samples of Death Records to show you the many different causes of death and how it is written.

Here are the statistics for the leading causes of death under the age of 75 in Grant County from 2015-2017 from "Robert Wood Johnson Foundation County Health Rankings". There were a total of 2,094 deaths from 2015 to 2017.
