Message from the Knox County Health Officer, Dr. Alan Stewart

The year 2025 was a challenging year for the Knox County Health Department. After two years of generous funding through continued support of our County and generous funding through the Health First Indiana funding initiative, the Health First Indiana funding was cut dramatically. The changes in funding required dramatic changes in the function of the Health Department. Program funding required significant reductions and, unfortunately, personnel reductions were required as well. The goal of the Health Department was to maintain the program initiatives that had been started while living within the curtailed budget.

The employees of the Health Department worked diligently to assume added responsibility as well as to continue programs that provided income. The core programs of the Health Department including immunization, vital records, sanitation and environmental services were all maintained. Educational programs within all Knox County schools continued and remained robust. Programs such as lead testing and evaluations, TB testing and treatment, STD testing all continued and grew. CPR training was continued as well. The highly popular tire and large item trash collection program will be resumed.

The successful vaping prevention, tobacco cessation and the alternative to suspension programs remained popular and in demand. This program received additional support from a grant which enabled the department to hire Valerie Roark as a TPC Program Coordinator.

Financial reorganization due to the loss of grants and the need to identify and accurately fund line items within the budget while working with the remaining funding to create a balanced budget for the coming year was accomplished by the newly appointed Health Department Administrator, Krystle Russell. Under her guidance all of the above was accomplished and the Health Department as a unit remains highly competent, extremely hard-working and functioning as a cohesive unit.

The coming year will continue to present challenges. We feel that with our present staff and leadership as well as the support of our board and many community partners, we will be able to fulfill our mission of continuing to provide high quality public health to the Knox County Community.

Department Reports

Administrator

Krystle Russell, CCHW, started in the role of interim Administrator in March of 2025, prior to March 2025, Krystle was serving the Health Department in the role of Community Outreach Coordinator. Krystle became the Administrator of the Health Department in May.

While 2025 posed a unique set of challenges with funding cuts and the need for the restructuring, Krystle, with assistance from Brian Taylor, was able to navigate the challenges and assist the Health Department in being the process of adapting to the changes. During 2025, Krystle worked to update records, implement systems for better tracking of funds, and budgeting for 2026. While learning the aspects of the role of Administrator, Krystle was able to learn more about programs such as ADP, learn about the functions of county government, and learn more about the work of the departments within the Health Department. All these skills will continue to be valuable.

Krystle was able to successfully write a grant and received funding from the Indiana State Department of Health Tobacco Prevention and Cessation. This grant funding allowed the Health Department to hire a TPC Program Coordinator, Valerie Roark. This grant funding will provide the opportunity for the Health Department to continue important work in tobacco control for Knox County.

Krystle attended several state led trainings and meetings throughout 2025 to continue to learn more about the role of Administrator, while continuing to learn more about public health and the vital services that public health provides to our community.

Medical Billing Specialist/Administrative Assistant

Brian Taylor continued his role as the Medical Billing Specialist/Administrative Assistant. Brian continued working with Good Samaritan to submit patient registration for Medicare/Private Insurance claims. In addition, he submitted and filed Medicaid claims for remittance. Brian also maintains the website for the Health Department by updating prices, staff information, hours, and updating forms as needed. He also assisted with the creation of items for the produce vouchers, FitKids

program, Germbusters program, and other events. Brian also serves as the backup for Vital Records as needed. In that role, he assists with receipting, documentation, and issuance of birth and death records. Given the change in Administrators in 2025, Brian stepped up to help ensure administrative duties continued providing guidance and help by ensuring records were updated, organized, and stored appropriately. He also helped with placing orders for items needed by the Department, while also managing inventory for county tracking. Brian attended two trainings offered by the state which included one training on strategic planning and one training on leadership.

Vital Records

Registrar Roxanne Kempfer, VRP-S, continued to serve our community through the issuance of vital records. Roxanne remained committed to refining her skills and knowledge in vital records by maintaining certifications and attending conferences.

In 2025, Indiana counties were allowed to print birth and death certificates for births or deaths that occurred in another Indiana County. Roxanne quickly created a plan and fee schedule for this new opportunity. For this first year of printing out of county birth and death certificates, the Knox County Health Department printed 92 out of county death certificates and 37 out of county birth certificates. This service offers members of the community to be able to obtain birth and death certificates without having to travel to another county.

Roxane also continues to explore opportunities to make the Vital Records Department run more efficiently and smoothly. Roxanne has updated internal documents needed to track revenues to help ensure effective tracking of income received into the Health Department. She also examined the cost associated with birth and death certificates and made recommendations to the Board on pricing for birth and death records.

Roxanne also maintained her Notary Public. Roxanne also represented the Health Department at the Vincennes PBS Family Fun Feast and is quick to help co-workers when needed whether that be helping to coordinate CPR or assisting with records keeping for the Immunization Department.

One of the highlights of Tara's year was the opportunity to work with The Pantheon in Vincennes to create a certified kitchen that will help small businesses, startups, or others who need access to a commercial kitchen in order to sale their food products.

Head Public Health Nurse

Cara Rivera, LPN, Head Public Health Nurse, continued to serve members of the community by providing much needed immunization services, testing services, and wellness checks such as blood pressure checks. Cara had the opportunity to collaborate with the Head School Nurse for one of our school districts and the Health Department's translator to contact parents of children that needed to be caught up on needed immunizations. Cara also completed the VFC provider agreement and worked to ensure that LTBI patients had access to needed medications. Cara also completed investigations on numerous communicable disease cases. Cara was also able to complete or participate in many trainings and certificates in 2025. Those included the following:

Part-Time Public Health Nurse

Karen Franklin, RN, Part-Time Public Health Nurse, continued to serve as the Health Department's representative on FIMR. Karen also began attending CAT (Community Action Team) meetings to represent the Health Department. In 2025, Karen played a pivotal role in our tobacco cessation program as she helped lead Freedom from Smoking sessions and one-on-one sessions at a local business for those who were interested in quitting smoking or vaping. Karen also assisted with screenings in one local school. Karen was also able to complete or participate in many trainings and certificates in 2025. Those included the following:

The nurses who staff the Immunization Clinic all worked together to offer a variety of services to the community. In addition to immunizations, the nurses also offered blood pressure checks, A1C testing, STI testing and treatment, and QFT blood draws and TB skin testing. The nurses hosted a few Saturday clinics at the Health Department to make access to our immunization services even more convenient. However, our nurses did not just stay in the Health Department to offer our services, they went out into the community to offer free blood pressure checks several times at the Vincennes Farmer's Market, attend the YMCA Senior Health Fair, went off site to local nursing homes, assisted living facilities, and businesses to offer Flu and Covid Immunizations, and offered Flu and Covid Immunization as the Men's Wellness Fair. The Immunization Clinic also passed the annual VFC Provider Certification with a 100% and no compliance issues.

School Liaison

Pamela Stewart continued to serve as the School Liaison. Through the effort of Pam and our paid volunteers the educational efforts of the Knox County Health Department continue to inform and equip our students to make good decisions for healthy lifestyles. Pam continued to build on solid partnerships with our school systems to help children learn to make wise decisions concerning nutrition, physical activity, dental care, and germ reduction. We continue to look for ways to work the county schools to identify and be of service.

The FitKids outreach occurs in the spring semester. Facilitators are trained to teach students to make healthy food choices. The third-grade curriculum centers on sugars, while the third-grade focus is fats. Manipulates and teaching models are used to show sugar content, the difference between fat and muscle, artery composition, and the importance of a balanced plate. We are grateful to have received an American Dental Association grant entitled, Give Kids A Smile. This enabled us to add a dental component to address the need for dental education and care for our students.

The Germbusters program occurs in the fall semester and is offered to pre-school and kindergarten students. With the interest of our facilitators, we added special education classes to our roster. This program centers on proper sneezing and coughing techniques as well as hand washing.

Hearing screening at North Knox was completed in November. The speech language pathologists always contact us early to determine the dates. This is helpful to lock in the dates not only for the school system but also for the screeners.

South Knox hearing and vision screening began in August and completed in November. Vincennes Community School Corporation uses us for high school hearing screening.

- **Fitkids**-877 county students and 39 classrooms were served in 2025.
- **Germbusters**-578 students and 36 classrooms were served in 2025.
- **Hearing Screening North Knox**- 408 students screened in 2025
- **Hearing and Vision Screening at South Knox**-647 students screened in 2025
- **Hearing Screening at Vincennes Community School Corporation**-142 students screened in 2025

Community Outreach

The Community Outreach Department underwent several changes within 2025. Krystle Russell transitioned from Community Outreach Coordinator to Administrator. Two community outreach positions were eliminated due to constraints in funding and the need to restructure the Health Department to meet the new funding provided.
