

# **PROPOSED HEALTH DEPARTMENT FLOOR PLAN**







# **ARCHITECT'S BUDGETARY COST OPINION**

#### SOFT COSTS:

A/E Design Fee

- 6.5% of \$1,179,282
- Multiphase/Temp Conditions Planning & Documentation

Loose Furnishings (furniture, appliances)

• Budgetary (undefined scope)

Fixed Technology

- Displays, Access Control, Security Cameras, WAPS
  - o Assumes some re-use/reinstallation of existing
  - o Excludes loose electronics (phones, computers, copiers, etc.)
  - o Budgetary (assumed scope based on similar projects and existing conditions)

Permits

- State construction design release, local building permit
- Builder's Risk Insurance (if required/desired)
  - By Owner, budgetary




