IC 16-20-2-11 Vacancies;

- (b) When a vacancy occurs, the original appointing authority shall appoint a qualified person to serve the remainder of the unexpired term. A local board of health shall provide to the appointing authority a list of five (5) individuals, at least three (3) of whom must have professional experience in one (1) of the following areas:
 - (1) Medicine.
 - (2) Nursing.
 - (3) Hospital administration.
 - (4) Pharmacology.
 - (5) Social work.
 - (6) Dentistry.
 - (7) Veterinary medicine.
 - (8) Engineering.
 - (9) Environmental science.
 - (10)Legal profession.
 - (11)School administration.
- (c) The list must include at least one (1) licensed physician. The appointing authority may select an individual from the list when filling a vacancy. As added by P.L.2-1993, SEC.3.
