

**ORDINANCE 2024- 01**

**ORDINANCE TO REVISE THE PULASKI COUNTY  
HEALTH DEPARTMENT'S FEE SCHEDULE**

**WHEREAS**, Pursuant to Ind. Code 16-20-1-27, the Pulaski County Health Board revises its established fee schedule due to increased prices; and

**WHEREAS**, the Board of Commissioners of Pulaski County have reviewed the revised fee schedule and approve the increases set forth below:

All VFC (Vaccine for Children) vaccines    Administrative Fee	\$15.00 each
