## *Mishawaka Office Reopening*

### *St. Joseph County Department of Health to reopen Mishawaka Clinic*

The St. Joseph County Department of Health is reopening its Mishawaka office, located in the County Services Building at 219 Lincolnway West, the Department of Health will provide Vital Records and an Immunization Clinic.

Vital records will be available Monday through Friday, from 8 am – noon, and 1 - 4 pm starting Thursday, January 2, 2020. The office cannot accept payment or process applications after 4 pm. The Mishawaka location will not offer paternity or corrections to applications. Forms of payment accepted: Cash, Business Check, Credit or Debit Card.

The Immunization Clinic will be open Monday, Wednesday, and Friday from 8 am – noon, and 1 - 4 pm starting Monday, January 6, 2020. The Mishawaka location will offer a full range of vaccinations. Forms of payment accepted: Cash, Business Check, Credit/Debit Card and Medicaid.

“In an effort to better serve the needs of the residents of St. Joseph County, we will be re-opening our Mishawaka location in January of 2020,” said Interim Health Officer Mark D. Fox. “Our goal is to increase access to these needed services.”

To re-introduce the community to the Mishawaka office, the Department of Health will host two special immunization events prior to the new year. The Immunization Clinic will be open on Wednesday, December 18<sup>th</sup> from 8 am - 11:30 am, and 1:30 pm - 4 pm for Flu vaccinations. On Tuesday, December 31<sup>st</sup> from 8 am - noon and 1 pm - 4 pm, the clinic will focus on required back-to-school vaccinations. Cost per vaccine varies (visit [www.sjcindiana.com](http://www.sjcindiana.com) for current fee schedule). Please bring valid ID and shot records. Minors must be accompanied by a parent or authorized guardian. Forms of payment accepted: Cash, Business Check, Credit/Debit Card and Medicaid.

Vital records and immunization services are also available in the South Bend location of the St. Joseph County Department of Health, located on the 8<sup>th</sup> and 9<sup>th</sup> floors of the County City Building at 227 W. Jefferson Boulevard.
