COVID-19 Cases Update

St. Joseph County- As of today, St. Joseph County is reporting 3,873 active cases (red as it relates to County metrics), and an average of 233 cases per day (red) over the last seven days. Test positivity rate is 12.9% (as of 12/7/2020) (red). The R0 is 0.87 (as of 12/8/2020) (yellow).

The distribution of a COVID-19 vaccine is an important development in COVID-19 response. While doses have begun to arrive in Indiana, we are months away from the vaccine being widely available and for us to begin to see the impacts of a vaccine on our COVID-19 spread. Therefore, individuals must remain diligent on risk mitigation strategies such as mask wearing, physical distancing, hand hygiene, and limiting of social gatherings. The SJC Department of Health will have more information on vaccine availability, when/where one can get the vaccine, and more, in the coming weeks.

Once our community is ready to administer mass doses of the COVID-19 vaccine, we will need our community's support through volunteers! Volunteer positions will consist of assisting with traffic flow, registration, or clinical services (if appropriate credentials). The St. Joseph County Department of Health urges the continuation of the following actions:
