Establishments not in Compliance:

Kat-A-Korner Diner (2 Non-Compliance)

- Observed dishwasher loading dirty dishes on rack and then unloading clean dishes without washing hands in between tasks
- No hand soap provided at 2 of 3 handwash sinks located in the kitchen

Cowtown USA (3 Non-Compliance)

- Observed raw eggs, fish and steak stored above ready-to-eat food
- Observed frozen fish filets and ribs thawing at room temperature
- Fly strips hung above dishwasher and meat slicer

Grillbillies BBQ (3 Non-Compliance)

- Measured hashbrown casserole, mac and cheese hot holding improperly at 95-106F
- Observed containers of chopped tomatoes, onions and pulled pork not date marked
- Observed establishment with excessive flies in the kitchen

Maddog's Restaurant & Bowl (3 Non-Compliance)

- No paper towels at handwash sink
- Observed ice chute with debris
- Pan of spaghetti noodles measured at 106F not hot holding properly

The Square Pub (5 Non-Compliance)

- No paper towels at handwash sink
- Observed brown debris around and inside ice machine
- Frozen ribeye steaks found thawing improperly
- Observed multiple flies in kitchen
- Establishment did not have chlorine sanitation test strips

Carlisle Plaza (5 Non-Compliance)

- Observed pink and brown debris inside ice machine
- Soda nozzles were found unclean
- Measured prep cooler at 60F, should be 41F or below
- Sandwiches, fried chicken and fish found being held in warmer longer than 4 hours, not temperature controlled
- Observed cardboard being used on several shelves in walk-in and kitchen; cardboard is not smooth and easily cleanable

Antonio's Mexican Restaurant (3 Non-Compliance)

- Measured a full pan of cooked ground beef made the day before at 54F
- Observed not using the proper cooling methods
- Upright cooler found dripping onto the food stored inside

Kroc's Butcher Shop (1 Non-Compliance)

- Observed leak under handwash sink by restroom and a clogged drain in the deli case

Elks Lodge #911 (2 Non-Compliance)

- Wings, grilled chicken and hardboiled eggs not date marked
- Rusted pizza screen and mini muffin pan found on shelf

Petty Pit Stop (2 Non-Compliance)

- Observed ham and sweet potatoes thawing on counter top
- Observed boxes of single use items being stored on the floor

Subway-Farmersburg (1 Non-Compliance)

- Observed black debris inside ice machine
