Establishments found out of Compliance:

China Wok (9 violations)

805 N Section St., Sullivan

- Employees observed eating food in the kitchen and food prep area.
- Observed employee washing hands in the wok on the cooktop.
- No paper towels available at the handwash sink in the kitchen.
- Observed raw chicken and shrimp stored above raw vegetables in the walk-in cooler and observed raw chicken and beef stored above a container of sauce.
- Observed employee washing and rinsing a container in the 3-bay sink without sanitizing or air drying before stacking it on other containers.
- Soda nozzles in the lobby were found unclean.
- Sugar, salt, MSG, cornstarch, and various made-in-house sauces not labeled with common name.
- Gap observed under the east and south kitchen doors.
- Buckets of diced potatoes and sauces were found stored on the floor of the walk-in cooler.

Prapti Inc./Marathon (8 Violations)

975 S. Section St., Sullivan

- Raw eggs observed in the cooler over raw potatoes. Raw chicken stored above raw fish in reach in cooler.
- Starbucks cooler storing food at 48°F internally, shall be kept at 41°F or less
- Batter dip for chicken found at room temperature and not marked with a time to discard.
- Packaged house-made cheeseburgers and other sandwiches not labeled properly.
- Excessive flies noted throughout the establishment

- No sanitizer test strips available to measure sanitizer levels
- Mop heads not properly air-dried after use
- Hole in the drywall behind 3 bay sink, exposing studs and pipes

Baesler's (7 Violations)

277 Section St., Sullivan

- Brown and white gravy in the hot holding unit found at 115°F; should be 135°F and above
- Hot bar holding breakfast burritos, hash browns, breakfast sandwiches, and breakfast potatoes at 110-120°F (discarded); should be 135°F and above.
- No thermometer found in the deli hot holding case.
- Several packaged items in the deli and bakery are not labeled with ingredients and allergens
- Drainboard of 3 bay sink in the produce area found unclean
- Racks and prep table in the meat cutting room were found rusted and no longer smooth and easily cleanable.
- Floors in bakery, ceiling in deli, storage rack in milk cooler, yogurt cooler, ceiling in deli walk-in found unclean.

Cowtown (7 Violations)

109 W Harrison St., Carlisle

- No paper towels at handwash sink
- Handwashing sink found with dirty rags and not accessible for handwashing
- Debris observed in ice machine and on vegetable slicer
- Sliced tomatoes, onions, and lettuce in containers on ice found at 68°F, shall be kept at 41°F or less
- Fly strip full of flies found in kitchen
- Observed boxes of potatoes wrapped in foil and buckets of flour, salt and sugar stored on the floor
- The microwave in the kitchen had debris inside on the plate, sides, and top

Backstreet Pizza (5 Violations)

523 S Section St., Sullivan

- Employees observed handling croutons with their bare hands
- Pizza pans found with burnt-on debris, which can harbor bacteria. Ice machine observed with pink and brown debris.
- Walk-in refrigerator observed holding ambient air temperature at 60°F. Boxes of ham, deli turkey, whipping cream, chicken nuggets, and chicken strips found at 49.9-53.6°F (discarded)
- Alfredo sauce found in a closed container in a reach-in refrigerator at 120°F, being cooled improperly
- Observed prepared salads on plates in the refrigerator, not covered or protected from contamination.

Sullivan Sunoco (3 Violations)

782 W. Wolfe St., Sullivan

- No paper towels at the handwash sink
- Handwash sink blocked by a large box of trash
- Debris observed inside the ice machine. Iced tea nozzle found with chunks of debris.

Marathon (2 Violations)

110 E Jackson St., Hymera

- Pizza, chicken nuggets, corndogs, and eggrolls not date marked, internal temperatures found at 110-118°F (discarded)
- Breakfast sandwiches in clamshells are not labeled with common name, ingredients, allergens, business name, and location

Joe's Italian Restaurant (2 Violations)

821 N. Section St., Sullivan

- Several sanitizer spray bottles are not labeled with contents
- Cardboard used to line shelves, not a cleanable material

Subway (2 Violations)

828 W. Wolfe St., Sullivan

- Observed a large gap under the back door
- Non-stick coating on bread pans is peeling or damaged and no longer smooth and easily cleanable.

Henry Bobe's Trattoria Italiano (1 Violation)

934 N Section St., Sullivan

- Observed soiled racks and shelves in the dough room. Ventilation hoods and filters found buildup of residue

Maggie & Moe's Food Truck (1 Violation)

- Cup with no handle stored in ice bin

VFW Post 2459 (1 Violation)

201 W Illinois St., Sullivan

- No sanitizer test strips available to measure Quat sanitizer in 3 bay sink
