Establishments found out of Compliance:

Prapti Inc/Marathon (9 violations)

975 S Section St., Sullivan

- Person in charge couldn't answer basic food safety questions.
- Raw eggs stored above sliced deli ham and biscuits. Raw eggs are stored on top of precooked egg rolls. Raw chicken and fish stored above boxes of mushrooms in reach-in cooler.
- Pink and brown debris observed inside the ice machine bin near ice chute
- Packaged breakfast sandwiches in the countertop warmer at cash register found at 119-131°F; should be 135°F or above

- Batter water at breading station found at 65° F; should be 41° F or less or discarded every 4 hours
- Frozen drumsticks found thawing on the countertop at room temperature
- No thermometers provided for countertop warmer, milk cooler, or Starbucks cooler.
- Packaged breakfast sandwiches not labeled properly.
- Mouse droppings observed in several cabinets under beverage stations where cups, lids, and napkins are stored.

China Wok (8 violations)

805 N Section St., Sullivan

- Observed raw chicken stored above cooked teriyaki chicken, raw chicken and beef stored above sauce, and raw shrimp above chopped vegetables.
- Soda nozzles in the lobby were found unclean
- Cold bar foods found at 48° F; should be 41° F or less.
- Observed raw chicken being thawed improperly
- Sugar, salt, MSG, cornstarch, and various made-in-house sauces not labeled with common name
- Gap observed under east and south kitchen doors
- Buckets of diced potatoes and sauces found stored on the floor of the walk-in cooler
- No sanitizer bucket made for wiping cloths used to clean the countertop where raw chicken was being prepared

Uptown Tavern (2 Violations)

8111 E. Main St., Dugger

- Large Gap observed under the back door
- Improper thawing of raw hamburger meat
