Establishments not in Compliance

The Junction -Shelburn (9 Non-Compliance) Follow up scheduled

- Need Certified Food Protection Manager at establishment
- No procedure for responding to vomiting and diarrheal events
- Handwash sink blocked, not able to access
- Sign or poster needed for employees to wash hands
- Measured TCS food out of cold holding temperature at 47F degrees
- Date marking missing on food items
- Need thermometers in all hot and cold holding equipment
- Observed seasoned flour, batter without proper working container labels

- No sanitizer test strips available in establishment

Jon's Union Station – (6 Non-Compliance) Follow-up scheduled

- Observed employee drink on prep table
- No handwash sink in kitchen area
- Measured chili hot holding temperature at 102F degrees
- Chili was not properly reheated for hot holding
- Baked potatoes, pulled pork measured at 50F and 59F degrees for cold holding
- Observed boxes of frozen food & other food in crates stored directly on the floor

Caseys #3633 – Shelburn (3 Non-Compliance)

- Measured egg patties at 64F degrees & 5 bags of scrambled eggs thawing on prep table
- Observed mop heads not properly air drying
- Observed floors throughout the kitchen, walk-ins & dry storage with food debris

Sullivan Sunoco –(3 Non Compliance)

- Observed sausage & egg patties without date marking
- Observed boxes of frozen pizza crusts and topping stored directly on floor & Observed employee food stored in the ice machine
- No sanitizer test strips

EI Patron – Farmersburg (2 Non Compliance)

- Measured chopped tomatoes, gauc, shredded lettuce, chorizo, raw hamburger and vegetable medley cold holding at 42 to 55F degrees
- Observed several cracked tiles in walk-in cooler

Fast Jacks – Graysville (2 Non Compliance)

- Observed accumulated debris on several soda nozzles
- Observed trash and other debris under beverages racks in walk-in cooler

Merom Camp & Retreat Ctr—(1 Non Compliance)

- No sanitizer test strips in establishment
