MANDATORY STEPS FOR OBTAINING A SEPTIC PERMIT IN WASHINGTON COUNTY INDIANA

- 1) Request and receive a Driveway Permit, from the **Washington County Highway Department, located at 600 Anson St, Salem, IN 47167, 812-883-3538**, prior to obtaining a Septic Permit.
- 2) Property owner or agent must fill out an application for the Septic Permit and pay the Septic Permit Fee of \$100.00, before the permit may be issued. Please also provide a legal description of the real estate and a COPY OF THE CURRENT RECORDED DEED OF RECORD AS FILED WITH THE WASHINGTON COUNTY RECORDER'S OFFICE, AS PROOF OF OWNERSHIP. (Must contain parcel number and address if it has been issued one). A copy of the issued Septic Permit will automatically be sent over to the Washington County Building Department for your convenience.
- 3) Must have a **Certified Soil Scientist** perform a soil test. (List attached)
- 4) Choose **Septic Installer**. The **Septic Installer must contact WCHD Environmentalist** and complete a plan review prior to issuing the septic system construction permit. Washington County's plan review form or a septic component manufacturer's form that provides similar clarity and detail must be used for submittal.
- 5) Stake out location of septic system with flags to prevent heavy equipment from driving over site while house is under construction.
- 6) Obtain your building permit by taking your Septic Permit, and proper documentation of land ownership, to the **Washington County Building Department, located at 601 Anson St, Salem, IN 47167, 812-883-0139**.
- 7) Obtain your 911 address from Washington County Addressing, 601 Anson St, Salem, IN 47167, 812-883-4962.
