Approval of the February 7, 2022 Minutes

Dennis Peters made a motion to approve the February 7, 2022 minutes, Justin Mast seconded the motion. The February meeting minutes were approved as written.

Treasurer's Report

Jeff Larmore shared the treasurers report and reviewed the expenditures so far this year. The Pack-Rat has been used this year. A portable restroom, and hand washing sink was requested by IFD for the attendees for an upcoming training. An upcoming cost is the HAZMAT technician course.

Committee Reports

District 5 Hazardous Materials Training & Advisory Council -Ron Troutt/Jeff Larmore

Ron Troutt shared there is a training coming up in April at IFD House 44, this training is focused on defensive measures. The May training is to be hosted by CSX. In June, a three organization (53rd CST, IFD, MCPHD) training on mass decontamination will be held. Bill Beranek asked Ron Troutt to review what CSX does at each of their railyards.

District 5 Hospital Emergency Preparedness Committee – Justin Mast/Anne Edwards

Justin shared there is no new report for Hazmat related incidents. Covid numbers and hospitalizations continue to decline.

Hazardous Materials Exercise Coordination Committee- Jeff Larmore

Jeff Larmore shared the request for quotes are still in the process, with hopes of them being sent out within the next week. The exercise is going to be a full-scale exercise at JCl Jones Chemical. The exercise will be held on October 12th,13th, and 14th. The goal is to have a concepts and objectives meeting by June.

Indiana Emergency Response Commission

The rostered member is not allowed to attend virtually for three consecutive meetings. Esmeralda Valague motioned to approve the addition to the by-laws, Amy Durocher Matthews seconded the motion. The motion has been approved.
