## IHCP updates FQHC and RHC encounter codes

Effective for dates of service (DOS) on or after October 1, 2020, the Indiana Health Coverage Programs (IHCP) will remove the Current Procedural Terminology (CPT<sup>®1</sup>) codes shown in Table 1 as valid federally qualified health center (FQHC) and rural health clinic (RHC) encounter codes.

The list of valid FQHC and RHC encounter codes is reviewed periodically to account for new and end-dated CPT codes and is available on the [Myers and Stauffer website](http://mslc.com/Indiana) at [mslc.com/Indiana](http://mslc.com/Indiana).



Table 1 – Codes no longer valid as FQHC and RHC encounter codes, effective for DOS on or after October 1, 2020

Procedure code	Description
80195	Sirolimus level
90681	Vaccine for Rotavirus (2 dose schedule) for oral administration
90696	Vaccine for diphtheria, tetanus toxoids, acellular pertussis (whooping cough), and polio for injection into muscle, patient 4 through 6 years of age
92618	Evaluation and prescription of non-speech-generating and alternative communication device
96376	Injection of drug or substance into a vein for therapy, diagnosis, or prevention, in a facility
99241	Patient office consultation, typically 15 minutes
99242	Patient office consultation, typically 30 minutes
99243	Patient office consultation, typically 40 minutes
99244	Patient office consultation, typically 60 minutes
99245	Patient office consultation, typically 80 minutes
99402	Preventive medicine counseling, approximately 30 minutes
99403	Preventive medicine counseling, approximately 45 minutes
99404	Preventive medicine counseling, approximately 60 minutes
